The committee approved the proposed changes and moved them forward to the VRB Committee for further consideration. Boze also commented on the review session and its progress. He expressed his opinion that all AOSCA VRB's should not use "No Action Taken" as one of its options. Applicants deserve a review of their applications, regardless of quality and shortfalls, and some feedback from the VRB on how to correct them. The Grass VRB took this approach in its recent session. The matter will be discussed at the upcoming VRB committee meeting.
