Doug Miller shared his idea that perhaps it was time for the Soybean and Corn Committees to be combined and this led to a discussion about restructuring several AOSCA committees. There was general agreement with the concept and Billy Skaggs suggested that the Board of Directors will consider this as they go through the process of restructuring the AOSCA office and transitioning to new staff members. The Board will put this topic on its action list.
